**Synopsis**  
**Portsmouth Paducah Project Office Technical Support Services Procurement**

This notice is considered to be a synopsis in accordance with FAR Subpart 5.2 for the Portsmouth Paducah Project Office (PPPO) Technical Support Services (TSS) procurement. Within 15 to 45 days from the date that this notice is published, the U.S. Department of Energy (DOE) Office of Environmental Management (EM) anticipates the issuance of a Draft Request for Proposal (RFP), 89303324REM000120, for the PPPO TSS procurement. The PPPO requires a TSS Contractor to provide technical and administrative support to assist the DOE with the oversight and management of: the clean-up activities, all phases of on-site contractor operations, including general construction activities and On-Site Waste Disposal Facility (OSWDF) site, geotechnical and design documents at the Portsmouth Gaseous Diffusion Plant (GDP)/site in Pike County, Ohio and the Paducah GDP/site in Paducah, Kentucky, services for Operations and Site Mission Support (OSMS) located in Pike County, Ohio and Paducah, Kentucky, and the PPPO located in Lexington, Kentucky, to provide various technical engineering support functions, information technology infrastructure and cyber security support, Safeguards and Security (S&S) oversight support, and general administrative support for all of the PPPO sites.

The PPPO TSS Contractor provides technical and administrative support to assist the DOE with the oversight and management across all five of the following major prime contracts in support the PPPO EM Mission:

- (1) Portsmouth Decontamination and Decommissioning (D&D) Project;
- (2) Paducah Deactivation and Remediation (D&R) Project;
- (3) Operations and Site Mission Support (OSMS) (consist of the Depleted Uranium Hexafluoride Conversion Project [DUF6] operations as well as other ongoing production and mission support activities);
- (4) Portsmouth Infrastructure Support Services; and
- (5) Paducah Infrastructure Support Services.

The PPPO TSS procurement will be conducted as a Small Business (SB) Set-Aside Competition. The Government does not intend to acquire a commercial item or service using FAR Part 12. The North American Industry Classification System (NAICS) code for this requirement is 562910, Environmental Remediation Services, and the small business size standard is 1000 employees. The new contract resulting from this acquisition will replace the contract awarded to Enterprise Technical Assistance Services, Inc. (E-TAS), which will expire March 31, 2025. The current E-TAS contract can be referenced at <https://www.energy.gov/pppo/pppo-contracts>.
