Environmental Management Consolidated Technical Support Services Procurement

This notice is considered to be a synopsis in accordance with FAR Subpart 5.2 for the Environmental Management Consolidated Technical Support Services (EM CTSS) procurement.

Within 15 to 60 days from the date that this notice is published, the U.S. Department of Energy (DOE) anticipates the issuance of a Request for Proposal (RFP), 89303322REM000114, for the EM CTSS procurement.

DOE requires a Contractor to provide objective assistance at the highest levels of program planning, definition, execution, and evaluation for DOE EM Field Offices and Sub-Offices in areas specific, but not limited, to Safety Management and Quality Assurance; Developing Tank Waste Strategies and Technologies; Developing New and Innovative Technologies for Waste Management; Supporting the planning and execution of EM Waste and Materials disposition; Developing Policy and Guidance on Regulatory Compliance; and Developing Policy and Guidance on Regulatory Compliance; and Developing Intergovernmental Stakeholder Programs. The new contract resulting from this acquisition will replace the current EM HQ CTSS Bridge IDIQ contract, #89303323DEM000087, the ordering period of which will expire December 21, 2024.

This procurement will be a total small business set aside utilizing the Small Business Administration (SBA) 8(a) program. The Government does not intend to acquire a commercial item or service using FAR Part 12. The North American Industry Classification System (NAICS) code for this requirement is 562910, *Environmental Remediation Services*, with a small business size standard of 1000 employees.
